

PWDCA NATIONAL FUTURITY STAKE

STEP 1 (of 3) Check List for Litter Nominations

1. Envelope containing nomination and nomination fee must be postmarked after breeding and before litter is whelped.
2. Breeder or Co-breeder of this litter is a member in good standing of the PWDCA.
3. Both sire and dam of this litter have "current" health records on file with the PWDCA Health Database at the time of nomination.

Current shall be defined as consistent with the requirements outlined in The Courier for breeding related ads. These requirements and effective dates are as follows:

Effective March 1, 2006:

- a. Both sire and dam must have an OFA number.
- b. Both sire and dam must have a current CERF number up to 120 months of age. (Please note: Effective November 17, 2003, the Courier ad policy was updated to allow a dog rated Optigen "C", "C1" or "affected" to be in compliance with ad policy provided it has a current CERF exam form with a sole diagnosis of PRA as the reason for failure.)
- c. Both sire and dam must be Optigen tested.
- d. Both sire and dam must be tested at NYU for GM1 and have a GM1 rating, or an AP rating.

Effective February 1, 2000 through February 28, 2006:

- a. Both sire and dam must have an OFA number.
- b. Both sire and dam must have a current CERF number. (Please note: Effective November 17, 2003, the Courier ad policy was updated to allow a dog rated Optigen "C", "C1" or "affected" to be in compliance with ad policy provided it has a current CERF exam form with a sole diagnosis of PRA as the reason for failure.)
- c. Both sire and dam must be Optigen tested.
- d. Both sire and dam must be tested at NYU for GM1 and have a GM1 rating, or an AP rating.

Effective January 1, 1992 through January 31, 2000:

- a. Both sire and dam must have an OFA number.
- b. Both sire and dam must have a current CERF number.
- c. Both sire and dam must have a GM1 rating, or an AP rating.

Effective October 1, 1990 through January 1, 1992:

Full disclosure for both sire and dam was required for GM-1, OFA, and CERF

Effective February 7, 1988 through October 1, 1990:

Full disclosure of OFA and GM-1 status.

4. Litter nominations for a breeding by frozen semen from deceased dogs will be subject to the PWDCA Courier breeding related ad policy in effect at the time of the dog's death. The date of

the dog's death must be recorded with the PWDCA Health Database and included on the litter nomination form.

Remember:

STEP 2 Puppy nomination prior to 5 months of age by breeder or owner \$25.00

STEP 3 Entry in Futurity Stakes Class at Specialty \$10.00
